Virtual Meetings

Meetings for Worship; Meetings for Worship with Attention to Business; and Weekly Forums:

Chapel Hill Friends Meeting has been using Zoom software as an online platform to hold Meetings for Worship; including meetings with attention to business, forums, social hours, and committee meetings. Friends are doing our best to sustain spiritual connections and support the life of the Meeting during the pandemic.

Ministry and Worship and the Zoom ad-hoc committee (<u>zoom@chapelhillfriends.org</u>) wish to make this experience as rich as possible. Even apart, we wish to come together in the Light. To aid this, we advise those attending of the following:

- On entering the Meeting for Worship via Zoom, everyone's microphone will be muted (you do not need to mute yourself on entry). We suggest remaining muted when not speaking to avoid background noise.
- · If led to share vocal ministry, the "Unmute" button on the bottom left of the Zoom screen is pressed. When finished speaking, the "Mute" button may be pressed in the same location.
- · We recognize you may need to move around and settle. If doing so Friends are asked to use the "Stop Video" option (bottom of screen next to Mute) your name or profile picture will display until pressing "Start Video" again. This will minimize visual distraction for others,
- There is an option on the upper right of your Zoom screen to select "Speaker View" for a large window for the current speaker or "Gallery View" that shows small windows for all participants.

The Ministry & Worship Committee reminds Friends that our traditional Quaker practice in Meeting for Worship, in-person or online, is to refrain from sharing vocal ministry more than once in the hour to give others space for messages. Though it may be more challenging online, we strive to listen deeply in the silence and be open to the leadings of the Spirit that may move us to speak.

Food Delivery to IFC while Meetinghouse is Closed

The meeting's IFC committee has devised a plan to make Friends' donations of food items to the IfC more convenient. 1. Please bring food items to the meetinghouse porch on first and third Wednesdays of each month. Canned goods are to be placed in cardboard boxes labeled "IFC." Place bags of food in the

plastic bin with a secure top. Members of the IFC committee will pick up the donations at 3:00 pm on first and third Wednesdays and deliver them to the Rosemary parking lot. This system will eliminate the need for individual Friends to drive to Rosemary street with food contributions, though you are still welcome to do that. The first day of food delivery to IFC from our meetinghouse porch will be Wednesday, June 17th.

- 2. Please do not leave food on the meetinghouse porch on days other than the designated delivery days first and third Wednesdays. Bring your food donations prior to pick-up time of 3:00 pm.
- 3. News and ACTION ALERTS from FCNCL

Friends Committee on North Carolina Legislation (FCNCL) continues to grow in strength and numbers as we work to promote state legislation and practices that are consistent with Quaker values and testimonies. With racial, social, and economic inequities intensified by COVID-19 and disturbing incidents of police violence and racism, there has never been a more compelling time to take action in NC!

FCNCL was founded in Spring 2019 and advocates for policies that support people of all cultural, religious and racial backgrounds; marriage and gender equality; violence prevention; civil and voting rights for all citizens; access to quality education opportunities; quality healthcare for all; an equitable and humane criminal justice system; environmental stewardship; and opposition to all forms of torture and extreme rendition.*

We have issued three ACTION ALERTS this spring urging friends to speak out on Medicaid Expansion, and Improving Mail in Ballot Procedures. Currently, we are urging friends to write letters to the editor and/or advocate to their municipal governments regarding Action against police violence - PLEASE SEE www.fcncl.org for more details.

FCNCL has issued a minute on anti-racism which undergirds all of our work:

"Because FCNCL recognizes that systemic racism is a long standing and continuing problem, it has committed to continually work towards becoming an anti-racist faith organization. The FCNCL Minute on Anti-Racism includes the following statement: "We recognize that as individuals and Quakers we have too often been blind to our own failings and to the part we play in perpetuating structural and institutional racism. In committing to the work of becoming anti-racist, we know that confronting our failures will be difficult and painful. Guided by faith and grace, we are willing to accept this challenge and to do the necessary work. We see this work as essential if we are truly to live our Quaker testimonies and recognize that of God in everyone."

- 1. Opening worship and query
- Query: How am I open to seeking clearness on matters of conscience, and how do I assist others in doing so?
- 2. Welcome and review of agenda.
- 3. The minutes from the May 17, 2020 Meeting for Worship with Attention to Business (MWAB) were approved as written.
- 4. Gwynne Pomeroy, Co-clerk of the Nominations Committee, presented the annual report for review in May. The final list of committee appointments was presented. Openings which remain include one for the Ministry & Worship (M&W) Committee, two for Piedmont Friends Fellowship (PFF), and one for the Carolina Friends School Board. We approved the committee roster with gratitude for the hard work of the Nominations Committee. See Appendix 1.
- 5. Maura Murphy, Treasurer, presented the final budget, noting that in these unusual times we lack the usual contributions. The only change from last month is that we added \$200 to the Publications & Communications (P&C) Committee to cover the cost of printing a new directory. A question arose about the funding for the Care & Counsel (C&C) Committee during these difficult times. We were assured that there is extra funding available if needed. In the Quaker tradition of being fiscally responsible, the finance committee has been conservative in drafting this budget. We approved the budget as presented. See appendix 2.
- 6. Carolyn Stuart, Co-clerk of C&C, presented a proposed Friend of the Court letter from our Meeting on behalf of a 35 year old African-American man connected to our Meeting community charged as an accomplice with heroin trafficking. The letter asserts he was unaware of the presence of heroin at the scene. Although he uses marijuana, he does not deal drugs for profit. We believe he was entrapped and unjustly imprisoned. We ask he be released from jail and court ordered to the Victory Program drug treatment program of the Durham Rescue Mission. Another treatment option would be TROSSA. He has learning disabilities and Attention Deficit Disorder (ADD). He has been treated for mental health problems his entire life and is on anti-depression medications. He is currently being seen by a psychiatrist at Freedom House. He is a homeless, destitute, and mentally ill African-American. His grandparents are well-loved members of our Meeting where he has visited many times. Our involvement in the Yoke Fellows Prison Visitation Program has given us understanding of the problems of mass incarceration of African-American men. This letter will go to his lawyer who will decide how best to use it. We approved the letter with great gratitude.
- 7. Jeff Brown presented the revised response to Piedmont Friends Yearly Meeting (PFYM) regarding how the Chapel Hill Friends Meeting (CHFM) opposes racism. After adding a few minor edits, we approved this response with gratitude. See appendix 3.
- 8. Sean Chen, Clerk of the Publications and Communications (P&C) Committee, presented the annual report. We discussed internet security, which has been improved, and how to access reports through our

web site in advance of MWAB. An upcoming project is to publish a new directory. As our web site is the "public face" of the Meeting, we do not post our directory on it. We accepted the report with gratitude. See appendix 4.

- 9. Monteze Snyder, Clerk of the Transition and Support Committee, presented the annual report. There have been limits on the activities during the quarantine but some support has been able to be offered to inmates at Orange Correctional Center. There is a new warden who is more supportive of volunteers as well as a new chaplain who has already reached out to the meeting. We accepted the report with gratitude. See appendix 5.
- 10. InterFaith Council (IFC) report will be postponed.
- 11. Next MWAB will be 9 am, Sunday, July 19, 2020 via Zoom.

Chapel Hill Friends Meeting, Summary of Anti-racist Activities

In response to the Piedmont Friends Fellowship and Yearly Meeting and the Friends General Conference on the topic of activities concerning anti-racism in Monthly Meetings, Chapel Hill Friends Meeting (CHFM) would like to share the following about the Meeting as of June 19, 2020.

CHFM is becoming more diverse in terms of race and ethnicity. The 11:00 AM worship usually attracts 70-80 participants. Of this number, often 10 to 15 are people of color. Included are regularly attending individuals, and inter-racial couples and families as well as visitors from the university and community. We are blessed to have diverse participation in the life of the Meeting. At each Meeting for Worship, a member of the Ministry and Worship Committee reads the following statement: "We joyfully embrace the full spectrum of the Light within, made visible through the participation of all people, no exceptions."

Due to many years of work with the Orange Correctional Center, the Chapel Hill Friends Meeting's worship experience is much more diverse, racially and socioeconomically, than ever before. The spiritual benefits are incredible. Members of the CHFM community participate in the Yoke Fellows program to be directly involved with the Orange Correctional Center (OCC) in Hillsborough, including sponsoring inmates to attend Meeting for Worship. The majority of inmates welcomed to our Meeting are African American. Chapel Hill Friends are grateful for regular opportunities to worship with current OCC inmates as well as former inmates who have become regular attenders.

CHFM's Transition and Support Committee has a mission to serve and support men at OCC as they transition from incarceration to the community. Also, the Returning Citizens Financial Assistance Committee accepts and disburses funds to help men coming out of OCC and joining our community. The committee works with the Transition and Support Committee, which serves as a clearinghouse for information for resources within the community to which the men can be referred for help.

Other activities include the participation of CHFM members in workshops on racial equity conducted by the Racial Equity Institute. Participants learned about research findings on racial inequity and how to be a catalyst for change.

In education, ongoing Meeting support of Carolina Friends School, including annual financial donations, four CHFM members serving on the Board of Trustees, and shared facilities, honors the school's founding mission to be inclusive and diverse. Trustees have received training from the Racial Equity Institute. A member of CHFM initiated and sustains a local group of "Coming to the Table," an organization "Working together to create a just and truthful society that acknowledges and seeks to heal from the racial wounds of the past, from slavery and the many forms of racism it spawned."

Members of CHFM have participated as individuals in numerous other community efforts to promote racial equity:

- The Hate-Free Schools Coalition's work with the Orange County School Board resulted in a ban on the confederate flag as well as other symbols of hate and derision.
- Orange County Justice United is working with the Orange County School Board and Orange County Schools to add African American and Hispanic staff and teachers. The School Board has augmented recruiting efforts among African Americans both for teachers and teaching assistants.
- Orange County Justice United organized five public actions and raised funds to launch a new affordable housing pilot project, involving master leasing.
- Successful organizing that banned the "check-box" in Orange County, Chapel Hill, Carrboro and Hillsborough in 2012 whereby application forms for public jobs no longer ask applicants to indicate if they have been convicted.
- Friends support efforts to reduce the large racial and ethnic disparity in incarceration in North Carolina.
- Friends are involved with community organizing against mass deportation of immigrants.
- CHFM members regularly participate in peaceful counter-demonstrations at Ku Klux Klan and other white supremacist rallies in Orange County.
- Friends are active with county and municipal NAACP chapters.

Racism remains a challenge in North Carolina. Months before the heightened awareness of and demonstrations against nationwide systemic racism in June 2020, Chapel Hill Friends Meeting members and attenders expressed their desire to do more in support of anti-racism and racial equity within and outside of the Meeting community. A focal point for Meeting efforts continues to be the Peace and Justice Committee.

Publications & Communications Committee Annual Report, June 2020

The P&C Committee establishes and oversees communication modes within the Meeting and beyond. The Meeting's website, https://www.chapelhillfriends.org, is the "public face" of the Meeting. It provides extensive information about the faith and practice of our Meeting in particular and the Religious Society of Friends in general. The weekly E-News bulletin, emailed to all who request it, contains news of Meeting activities. The printed monthly newsletter contains announcements and Meeting for Worship with Attention to Business minutes. The committee also publishes an annual Directory of Meeting members and attenders, committee members, and appointees. It also establishes and oversees email addresses for all the Meeting's clerks.

Highlights

- The format for the weekly email (*eNews*) has been substantially improved for usability and access for readers using mobile devices and email software.
- A weekly email *eNews* is assembled by Buzz Borchardt and is distributed to members and attenders through a Google Group email list. Submissions continue to be accepted through news@chapelhillfriends.org.
- With the COVID 19 crisis there has been a surge in timely messages through *In the Light* alerts to the Chapel Hill Friends Meeting News Google group.
- The Meeting's website was completely redesigned in early 2019 and went live in April 2019. Features for the new website include: secure access through https, version control of the content through GitHub, a new publishing platform using GitHub Pages, and updated an analytics configuration using Google Analytics.
- From May 2019 to April 2020 there were over 11,970 page visits from 3,247 unique visitors.
- o The most popular pages beyond the home page include the glossary, forums, visit and learn, and the newsletter.
- o A feature using the Twitter platform allows CHFM users to post updates to the website easily.
- A monthly *Newsletter* is published in print under the guidance of Peter Malone. The deadline for the *Newsletter* is the evening of the last First Day of the month. Many thanks to Peter for his diligence and skill in putting the newsletter together. This task requires a great number of communications points including working with the Clerk of Meeting, Recording Clerk, members of the Publications and Communications committee, and all of the members and attenders who submit items to the *Newsletter* and to the *eNews*.
- The directory was not published in 2019, work on an updated directory is being discussed. Please contact news@chapelhillfriends.org for the latest version.
- We continue to post Meeting for Worship with Attention to Business agendas and supporting documents as needed by the Clerk of the Meeting.
- Adding new subscribers to the weekly *eNews* .

Looking Ahead

- We'd like to thank the *Zoom Working Group* for getting the Meeting's life and activities online. As communications needs change the committee looks forward to doing what is necessary in order to make sure the work and community of the Meeting continues.
- Working on the next version of the Meeting Directory.
- Setting up more regular meetings and work sessions.

Transition and Support Committee Annual Report April 2019 to April 2020 Presented April 19, 2020 MWAB

This report covers our activities as we continue to serve men in Orange Correctional Center (OCC) as well as those whom we support when they return to the Chapel Hill community. Most of these activities have included volunteers from the Meeting in addition to the Transitions and Support Committee. Note that this report was written before all our activities with the men in OCC were suspended in March due to the coronavirus pandemic. Support teams have maintained contact with men who have been released or who are anticipating release by the summer.

Yokefellows at OCC: Along with other volunteers we attended Tuesday night meetings of Yokefellows at the Peace Center three times per month. Seated at round tables of two volunteers and four men, we got to know some of the men; these conversations also facilitated finding out who wanted to attend Meeting for Worship, the book club, and possibly requesting a support team when they are released. Paul Munk took several men to addiction recovery meetings in town. Last year Bonnie Raphael assisted one of the men in getting his life sentence reviewed by the Innocence Project at Wake Forest Law School; a change in his sentence is still pending.

Financial Support of Alamance Orange Prison Ministry: As many in our Meeting are aware,

Financial Support of Alamance Orange Prison Ministry: As many in our Meeting are aware, we conducted an annual fundraiser to support the chaplain and the ministry's activities at OCC. Richard Miller continued to coordinate the sale of walnuts this December, which generated \$1,290, the highest volume of sales among congregations participating in Yokefellows. We note that our youth supported the Ministry in the holiday Alternative Gift Market, resulting in an additional contribution of more than \$800.

Meeting for Worship at OCC: We had two meetings for worship last year at OCC and have meetings for worship scheduled this year for Sunday, August 9 and Sunday, October 4. Let us know if you would like to join us.

Current and former OCC residents in Meeting for Worship and other events at CHFM:

Men from Meeting served as sponsors to bring one to three eligible men to Meeting for Worship, forums, and potluck. Returned citizens have also joined us for worship.

Following potluck each month we gathered with current OCC residents, returned citizens and members of the committee and other interested volunteers from the Meeting at large for discussion of issues of interest and concern for the group. We have considered some of these issues for discussion with prison administration when feasible. These conversations have been useful helping men plan their housing, employment, transportation and other details of their next steps after release and for us in our support. We understand that these gatherings and the

Tuesday night Yokefellow meetings have helped the men break barriers among them in the prison.

Other support to friends at OCC: We participated in various events at OCC such as Parents Day, Black History celebration (now an annual event), and special meals prepared by the Cooking Class for Fourth of July and Thanksgiving. We hosted a birthday party on August 27 for men whose birthdays fell in that month. As volunteers through the Orange County Literacy Council, Maria Darlington, Bonnie Raphael, Paul and Joyce Munk also tutor men who are taking classes. With a new warden at OCC and recent additions in staffing in the Programs area, we hope for possible improvements in work release.

Crossing the Fenceline Book Club: Initiated by Tom McQuiston the book discussion group met on the fourth First Day of the month following Meeting for Worship at Fly Leaf Book Store. Six to nine men from the prison and others from the Meeting and T&S Committee participated in the discussion and shared pizzas. Multiple copies of the books were provided by local libraries. Travis Mason and then Nathaniel Picard have served as the OCC coordinator this past year, making sure the books are shared; Nathaniel has recently initiated at a Thursday 2 pm discussion group at OCC prior to the last Sunday meeting at Fly Leaf. This permits more men to participate who may not be able to attend on First Day.

Support Teams and Returning Citizens: Since March 2016 TSC teams have provided support for 21 returning citizens, and we continue to enjoy friendship with and support of a number of these men. This year we have supported 3 men in their returns to the area: [names for our use only: Michael Conway (re-release this year and now Relapse and reincarcerated), Aaron Hayes (re-released this year) and Ira Jackson. Last year: Anthony Clark, Michael Conway, Aaron Haynes, Ed Harris] and reinitiated assistance to two men {James Bony and David McDonald} who have returned to IFC Community House.

When returning citizens were released, our support circles of 2-3 people assisted them in obtaining necessary clothing from socks to winter coats, transportation to Social Security and government agencies, medical appointments, and job interviews. Finding employment and housing were sometimes recurring challenges for an individual and for our teams in supporting them. When more permanent housing was located, we assisted in locating and providing furnishings; on rare occasion, members have assisted with loans for rent deposits and facilitated referrals to the Returning Citizens Financial Assistance Committee.

Beyond this logistical support, relationship building is the greater part of our effort. Most of our time and energy goes to building friendships and offering support over coffee or meals. Occasionally, we continue to support returned citizens when they re-enter the criminal justice system, attending court hearings, speaking to attorneys on their behalf, and visiting them in jail and prison, and writing those who are at a distance. Please let us know you if have contacts for possible housing or employment.

Annual Picnic: This year we held our third annual Reunion Picnic at Southern Community Park in September, inviting 80 men with whom we have worked over the past several years. About 30 attended, including some family members, attended. We sponsor the picnic for returned citizens and Friends to renew old friendships and share about their successful re-entry strategies. While attendance was lower than last year, we decided to repeat this event in the fall of 2020. Friends are invited.

Returned Citizen Support Groups: In addition, two groups of the returned citizens are have been meeting in friendship and support of each other. Tom McQuiston has Wounded Healers for returned citizens who also work with young people in the community and a friend who returned recently also hosts a group. To advance the development of these groups, Tom obtained at large grant to train peer mentors.

Transition and Support Committee: Finally, our Committee meets the last Tuesday of the month to coordinate team support for individuals and to coordinate our interaction with other organizations and programs. When policies and operations at IFC Community House changed this year, we researched other recovery and transitional housing for former inmates in Orange and Durham Counties. We shared our list with OCC program staff and other re-entry personnel, who said it was much appreciated. Nancy Fisher is working with a newly created nonprofit that seeks to establish a house for returning men in Hillsborough. Asta Crowe and Richard Miller are

members of the Local Reentry Council and the Citizens Resource Council. Hank Elkins is involved with Justice United and other initiatives related to appropriate housing and for mental health for returning citizens.

Our committee membership this year included Asta Crowe, Maria Darlington, Hank Elkins, Timothy Fogarty, Nancy Fisher, Tom McQuiston, Richard Miller Joyce Munk, Paul Munk, Bonnie Raphael, David Schneider, Monteze Snyder (current clerk), Byron Stevens, and James Taylor (JT). We anticipate several vacancies in July as long-term members rotate off of the committee while remaining active in other work. Please let us know if you are interested in possible nomination.
