Short Biography of Karen Merrey

I was born in Buffalo, NY and grew up in Shrewsbury, MA. After attending Northeastern University in Boston, I married my high school sweetheart, and we joined the Peace Corps. We taught ESL in an Indian market town and then entered a Ph.D. program at the University of Pennsylvania in Philadelphia. Upon completion of other requirements, we spent 2 years in Pakistan, where we taught anthropology for one semester at Qaid-e-Azam University and then spent 18 months in a Punjabi village doing ethnographic research for our dissertations. After completing my Ph.D. in anthropology, I later got an MPH as well.

My husband's interest in irrigation got him jobs in Sri Lanka, Indonesia and South Africa. I accompanied him to these places but did not often work for pay. I did volunteer work. Among my more interesting endeavors were organizing a committee to improve an orphanage in Sri Lanka; preparing a directory of organizations involved in combatting AIDS; organizing and chairing a series of 4 workshops to offer recommendation to the Sri Lankan government on revising their public health laws in response to the threat of AIDS; serving on the board of the Community Front for the Prevention of AIDS; working for the Sarvodaya Shramadana Movement; fundraising for an orphanage in South Africa; serving as program officer and then secretary of the Pretoria Soroptimist Club.

As a teenager, I was confirmed in the Congregational Church. I joined the Society of Friends in about 1980 after reading Peaceable Kingdom by Jan de Hertog. I belonged to meetings in Media, PA and in Sandy Spring, MD before coming to this area in 2011 from South Africa. I am very happy to have found such a congenial Friends meeting in Chapel Hill.

Chapel Hill Monthly Meeting of the Religious Society of Friends Meeting for Worship with Attention to Business May 20, 2012

We opened in worship and considered the query: How do we celebrate as a community? Several Friends responded:

- * One way is our First Day worship. It is an expansive experience each week to come to meeting and be with like-minded people.
- * I find the query hard to answer: I didn't come to worship for community, but to find the light of Christ within.
- * What do we mean by community? We all fall short, because community must include all of life and all that supports life.
- * I think that community has a lot to do with gratitude, sharing, listening, speaking, and connection with each other.
- 1. Clerk Carolyn White welcomed Friends, particularly first time attenders (Tom Ludlow, Karen Durovich, Colyer Durovich) and reviewed the agenda.
- 2. The minutes of the April Meeting for Worship with Attention to Business were approved as published in the newsletter.
- **3. Membership transfer:** Friends approved the transfer of membership of Karen Merrey from Sandy Springs Friends Meeting, MD. Carolyn will write up a short bio for the newsletter. Marilyn Dyer and Carolyn will form a welcoming committee.
- **4. Letter for Conscientious Objector Position (attached):** Colyer Durovich presented a letter requesting our support of his position as a conscientious objector. Friends expressed their gratitude and warm appreciation to Colyer for his eloquent letter; his summary of our basic beliefs gives us hope for the future. We also appreciate his commitment to be part of positive change. Friends accepted his letter and our clerk and two trustees witnessed it.

5. Response to PFF about becoming a yearly meeting: Carolyn reminded Friends of the recent history of our considering whether to join a yearly meeting and/or to help Piedmont Friends Fellowship (PFF) become a yearly meeting. We have received a request from the clerk and representatives of PFF to respond to the following question by the end of May: Is your meeting interested in participating in the development of a yearly meeting should we be led to proceed in this way?

We **approved** the following response, which reflects early communication to PFF following our December 3, 2009 appointed meeting: *Members of Chapel Hill Friends Meeting have benefited greatly from being a part of Piedmont Friends Fellowship over the years. We plan to continue to participate and support PFF, but we are not led at this time to participate in the development of PFF as a Yearly Meeting.*

- **6. Nominations Committee Report (attached):** Jeff Brown, clerk of Nominations Committee, presented the list of names proposed for service on CHFM committees and highlighted several committees where additional help is needed. Names for Ministry and Worship, Care and Counsel, and Carolina Friends School Board are still undergoing final discernment. They will be circulated before the June Meeting for Business. The entire list of names is held over until the June Meeting for Business for approval.
- 7. Finance Committee (attached): Matt Drake, clerk of Finance Committee, presented the proposed budget for 2012-2013. Copies of the proposed budget will be made available to Friends after the meeting (with the Treasurer's apologies). Matt reminded Friends of the decisions we had made last year reflecting use of income from building use for ongoing building renovations, income from parking for YRE activities (after paying the Unrelated Business Income Tax to the federal government), and income from donations to the meeting from individuals (to support committee work and our donations to other organizations [benevolences]). Matt reported that donations have been lower this year for a variety of reasons, such as a loss of some givers not balanced by new givers and reduced gifts from some givers, although most have kept their gifts at about the same level. As a result, the Finance Committee has based next year's budget on an expected income of about \$58,000. Committees' expected expenditures are a little lower than last year, but we still anticipate having about \$5,000 less for our benevolences in next year's budget. Finance Committee will monitor income and report again in the fall if the committee anticipates that income will differ significantly. One Friend asked that we look at our budget in terms of our carbon footprint. Final consideration and approval of the budget are held over until the June Meeting for Business.

Matt also announced that we will be moving our checking and savings accounts from Bank of America (BoA) to BB&T (Branch Banking & Trust) by the beginning of the new fiscal year on July 1st. The move was prompted by several Friends' concerns with BoA's involvement with the loan crisis and other practices not in keeping with our values.

8. Supporting the IFC's Good Neighbor Policy (attached): Dottie Heninger reported that the 75th anniversary subcommittee of the Ministry and Worship Committee had been working on finding ways to reach out to the community organizations with whom we have had a long-standing relationship. As part of this process, they talked to Chris Moran, director of the Interfaith Council (IFC). He requested that the Meeting consider a letter of support to the Chapel Hill City Council for the IFC's Good Neighborhood Policy, which has been developed as part of the process of seeking approval to build a building for a shelter for homeless men (and other services) on

Homestead Road. We **approved** the proposed letter (with minor changes). Carolyn and Dottie will ensure that the letter is signed and sent to City Council.

On behalf of the subcommittee, Dottie also asked that we commit to sending individual supporting communications (letters, emails, phone calls—we hope for 75!) and distributed information from IFC that will be helpful in those communications. They need to be sent by next week after the Council receives the Policy and before the vote. We hope also to have as many people from the Meeting as possible attend the City Council meeting to encourage moving ahead with the IFC building project. Friends are encouraged to provide copies of their communications to the meeting (in the Clerk's box) for our archives.

- 9. Peace and Social Concerns Annual Report (attached): Sarah Grimme, clerk of the committee, presented highlights of the report, which had been made available before the meeting. The committee has had another active year. Projects included support for the Bring the Money Home project, including working with local representatives and Friends Committee on Legislation; working with NCWarn to oppose local rate hites for energy companies proposing to build nuclear power plants, working with local organizations against ratifying the recent amendment to the NC constitution making one man/one woman the only legally recognized domestic union; working with incarcerated men, both in prison and as they are released; working with People of Faith Against the Death Penalty; supporting the Occupy and 99% movements. We noted that the Environmental Concerns Committee, the Bridging the Faith Divide subcommittee, and the new Prison committee have all come out of Peace and Social Concerns work. Friends accepted the report with great thanks.
- 10. Publications and Records Annual Report (attached): Emily Buehler, clerk of the committee, presented highlights of the report, which had been made available before the meeting. During the past year, the committee has moved the listserve to Google, allowing an easy way to subscribe or unsubscribe; begun having the newsletter printed by a local printer who uses 100% recycled paper for the same cost as Kinko's; and monitoring the use of printed newsletters, reducing the number to minimize waste, and making the newsletter available as a pdf file on the website. More information from committees now appears on the website and the committee will be polling people about possible improvements to the website format. In addition, the committee has been working with Ministry and Worship and Care and Counsel to clarify the role of Meeting Recorder and provide better guidelines for carrying out the responsibilities of the position. Friends expressed their appreciation for how quickly announcements are made available to listserve participants. The report was accepted with warm gratitude.
- 11. CFS Board Minute: Friends reflected on the following minute recently approved by the Board of Trustees of Carolina Friends School and presented by Matt Drake on their behalf. In light of the passage of the North Carolina constitutional amendment that defines marriage between one man and one woman as the only domestic legal union recognized in North Carolina, the Board of Trustees of Carolina Friends School re-affirms support for the school offering medical insurance and other benefits to Carolina Friends School employees and their families as we have defined them in our community, including domestic partners irrespective of gender, and their dependents. The recently passed constitutional amendment is inconsistent with our school's values and practices, and we support the Carolina Friends School administration's commitment to continue to treat all of our staff and their families with equality, integrity and compassion

Conscientious Objector Letter

May 20, 2012

Dear Friends.

I am writing this letter to make known to the meeting my personal decision to recognize and declare myself as a Conscientious Objector. As the Selective Service does not provide any official process for gaining recognition as a Conscientious Objector, it is up to me to organize a portfolio to document both my decision and my personal beliefs, reasons, and values that have led me to this decision. I request that two representatives of the meeting sign this letter as witnesses and also ask that the meeting keep a second signed copy of this letter as a record of my current beliefs.

Throughout my life - or at least for as long as I can remember - I have been morally and ethically opposed to violence. I believe all violence - including that framed as conflict resolution, self defense, or fighting for the greater good - is evil, as all violence increases the pain, anger, and distrust in the world. I refuse to support such a corrosive degradation of human society and general well-being. I am especially opposed to warfare - again no matter the circumstances or justifications. I value each and every human being. It makes no difference to me what they believe, what they own, where they live, how they think, what they think of my country, or what they think about me. It makes no difference if they are freely participating in war against my country, or if they would willingly kill me. I see something - a light - that universal spark of humanity - in everybody, and I cannot, could not, and will never under any circumstances be able to bring myself to snuff out another human being and deny them the opportunity for life. Although I have always been of this mindset, my beliefs have been strengthened, bolstered, and supported by my Quaker upbringing both at home and at the Chapel Hill Friends Meeting, which I have attended since early infancy. The only thing I will agree to do to another human being is to show them compassion. Only in such a way can any improvement be made in the world. War is an evil chain - with each death, a family is ruined and friends are torn by anguish. Anger boils and the survivors seek revenge and compensation through more war and violence. The cycle continues. Some would say this is an endless circle. However, I disagree - the chain of war can be broken - but only through conscientious efforts at compassion and understanding.

I know that many other pacifists choose to accept non-combat positions in the military. I am <u>not</u> willing to accept such a position as I would still be supporting the activities of the military. In other words, although I, in theory, would be able to keep my own hands clean, I would still be supporting and, in a larger sense, participating in the killing of my fellow human beings. Therefore, I am claiming 1-O Conscientious Objector classification for exemption from all training and service in the military. In place of military service I will be happy to to serve our country, and humanity as a whole, by volunteering to help change the world for the better.

Dear Mark Kleinschmidt.

The Chapel Hill Friends Meeting helped to start the Inter-Faith Council in the 1960's. Our interest in its evolution since has not waivered. We continue to volunteer at the IFC, cook lunch the first Thursday of the month, contribute financially every year as a Meeting and frequently as individuals, and offer nonperishable foods monthly for the food pantry.

This year our Meeting is celebrating its 75th anniversary. We are taking this occasion to affirm our support for the IFC, specifically to endorse its Good Neighbor Policy. The policy clearly follows the requirements the Town Council established in Resolution C, and provides an ongoing process to address community concerns related to the new shelter as they may arise. CHFM particularly endorses the implementation of the Advisory Council as an important part of the GNP.

We understand that IFC's transitional housing concept is good for the homeless population of our community. More fundamentally, we also understand that the project is good for all of our community, for our children, our elderly, our businesses, our faith communities. It exemplifies the caring community we want to be.

Chapel Hill Friends Meeting encourages you and the Town Council to support the GNP of the IFC at the Town Council Meeting on June 11th so that the building of the shelter may begin. To delay building would be a significant disservice to our community.

Peace and Social Concerns Committee Annual Report

Committee Description: This committee is responsible for providing a focus for these issues. It helps the Meeting be aware of background and current information, it publicizes opportunities for action to bear witness to our concerns, and it provides linkages between the Meeting and other groups in our community and beyond.

General Meeting Work

- · Researched and drafted a recommended benevolence plan to the Meeting as a whole
- · Currently working on the FCNL priorities process

Peace and Social Justice Concerns

- Members of the meeting met with David Price on ending the conflict in the Middle East and diminishing funds spent on the military and violent operations
- Continued to communicate with Rep. Price and Walter Jones through letters on these issues
- Members met with Walter Jones on bringing the troops and the money home. He is an active supporter of this cause
- Participated in a February 20th action at the legislative offices to bring the money home to fund domestic/humanitarian issues.
- Members worked with NC Warn to protect the energy rate hikes and the creation of a new nuclear power plant.

Judicial Equity

- Signed on to the People of Faith Against the Death Penalty action to stop the death penalty in favor of life sentences without parole (compromise)
- · Members worked to create opportunities for individuals recently released from prison
- · Members continued their outreach through the Yokes Fellows Program

OCCUPY

- · Members of the Occupy movement participated in a Peace and Social Concerns meeting
- · Held an adult religious education event after the meeting with occupy protestors to educate the meeting on the movement
- Members in many capacities have been working with Occupy across the state and nation to promote many issues.

Community Groups

 Continuing work with Orange JUICE, HK on J, Religious Coalition of Orange Durham County Against Amendment 1, NC Warn, Abrahamic Initiative for the Middle East, and Orange County Peace Coalition.

Publications and Records Committee Annual Report May 2012

This past year, P&R continued to manage the biweekly listserv, website and online calendar, In The Light announcements, monthly newsletters, and annual directory. As the fiscal year ends, we look forward to improving the Meeting website.

Highlights:

- We moved the listserv emails to a Google group. Friends and newcomers can now subscribe/unsubscribe themselves at http://www.chapelhillfriends.org/contact.html.
- We switched to a local, environmentally-conscious printer and 100% recycled paper for the newsletters and directory. By altering the format of the newsletters (larger page size, smaller margins), we kept the cost the same.
- We're keeping track of leftover newsletters so that, as Friends switch to using the online version, we can print less. (We are down to 60 copies a month, and less in the summer.) When a new newsletter is posted online, a link is placed at the top of the listserv. Friends can follow the link to download the newsletter as a PDF, which they can keep on their computer to reference.
- Reminder: Friends can also request the Directory as a PDF. (It is not online for privacy reasons.) Just email publicationsandrecords@chapelhillfriends.org and ask.
- With the help of many Friends, we produced the 2012 directory by New Years. We used a mass email to reduce the number of homes we had to call.
- With the help of Robin Harper, we expanded the "Guide for Clerks" documents online.

New Directions:

- We plan to update the web site design in 2012-13 and will start by talking with members and attenders about what improvements they would like to see.
- We have begun a discussion with Ministry and Worship, Care and Counsel, and the Record Keeper about codifying the role and duties of the Record Keeper.
