National lobbying opportunity

On February 17, 350.org is planning a massive demonstration in Washington, DC to oppose the proposed Keystone Pipeline. This pipeline is slated to carry bitumen from the vast tar sands of Canada across the US to oil refineries on the Gulf of Mexico. Bitumen extraction requires extraordinary environmental degradation to produce extremely dirty oil, and if completed the project would raise global CO2 to levels that NASA climate scientist Jim Hansen has said would mean "game over for the planet." IFC Update

The IFC met both of their 2012 challenge grants. The first, for meeting the increased needs of the local poor and hungry at the emergency shelter and at the Women's and children's shelter (Project Home Start). The second, for funding to proceed with building the new Men's Community House to be located at the intersection of MLK Boulevard and Homestead Rd. Appreciation and many thanks to those of you who contributed and helped the IFC meet these twin grants!

At the same time, the IFC is initiating a "Food First" project to merge the Rosemary St. shelter kitchen with the IFC food distribution program in Carrboro.

So it's busy times, and the number of people in need is growing, while government funds are drying up. The IFC has hired a consultant to help raise money for building the new Community House. The goal is four million dollars over five years. More information about the campaign will be coming.

The IFC currently needs tuna, canned fruit, and soup. Bring your donations on the first Sunday of the month, leaving your contribution in the IFC basket in the foyer at CHFM. Or, write a check and put it in the envelope in the foyer. Everything you contribute helps the poor in Chapel Hill and Carrboro!

Paul Munk Named Volunteer of the Year

Paul Munk has been named Volunteer of the Year by the Chapel Hill/Carrboro Chamber of Commerce for his work with the Alamance-Orange Prison Ministry. Dave Nickel, chaplain at the prison, recommended him with this letter:

Over the past half-decade, Paul has shown himself to be compassionate (but not naive) to a segment of our population that doesn't normally receive compassion from others. He is a father-figure to men who often don't know their fathers, and, if they do, they almost never describe their fathers as "compassionate."

Paul's compassion is consistent to men whose lives seem to be defined by inconsistency and only know "consistent" as a fence and officers whose primary task is to consistently keep society safe from them.

Paul's compassion is humble and quiet. He does not volunteer countless hours each week to be recognized or to win accolades, and he never uses words to announce his presence or his accomplishments. It seems he would prefer to do his good work unnoticed.

But Paul does make a difference to so many men at Orange Correctional Center, and his compassionate witness needs to be recognized.

Please take this opportunity to say thank you to all of our members and attenders who do such good work for the men at Orange Correctional and who, in the process, enrich our Meeting so greatly.

Richard's biography:

Richard Barnes, a convinced Friend of 38 years, was born in Richmond, Virginia, received a B.A. from the College of William and Mary, a M.Ed. from the University of Rochester, and did extensive graduate work at the Boston University Graduate School of Religion. He and his wife, Mary and their two children, were students at Pendle Hill on an Eli Lilly Foundation grant for a year in 1977-78.

A founding member of Maury River Friends Meeting in Lexington, Virginia, he has served as clerk of his monthly meeting and Virginia Half-Years Meeting. In 1997, he and his wife, Mary, served as co-clerks of the FGC Gathering of over 2200 Friends at James Madison University in Harrisonburg, Virginia. He served as clerk of the Quaker Universalist Fellowship for 10 years and has been a workshop leader at several FGC Gatherings and at three different yearly meetings. He and his wife, Mary, served as Friends in Residence at Pendle Hill during the spring term of 2011.

After serving 24 years as a teacher, counselor, and administrator in Virginia public schools, he served five years as director of development at Pendle Hill, a Quaker Center of Study and Contemplation, in Wallingford Pennsylvania from 1997-2001. After leaving Pendle Hill, he served seven years fundraising for various Friends organizations and as a fundraising consultant with HFreeman Associates. He estimates that he has made personal face-to-face visits in the homes of over 300 Friends in over 20 states.

Retired, he has a large organic garden, cuts his own firewood, and lives in one of the least populated counties east of the Mississippi River. His interests include mindfulness meditation, mysticism, spiritual discernment practices, and the parallels between the early Quakers and what Marcus Borg and Dominic Crossan today call "emerging Christianity".

Stewardship Workshops Quaker values and personal financial decisions February 9-10, Charlotte Friends Meeting

Quakers have a long tradition of building our lives around our values. It has never been enough to simply profess belief in an ethical or moral philosophy – beliefs should lead to action. That is why Friends have so often been at the forefront of positive social change. This same practice should apply to how we handle our money. It is important to financially care for ourselves and our loved ones, but how can we do that in ways that also support Quaker values?

Charlotte Friends Meeting (CFM) is hosting two workshops on this topic. The facilitators, Larry Jalowiec from Friends General Conference and Glen Kaufman from Everence (formerly Mennonite Mutual Aid), will provide information and perspective in considering financial stewardship issues in our own lives.

A will is a basic planning document that everyone should have, yet the majority of people have no will or the will they have is outdated. But a will is only the start. Good estate planning should include advance medical directives, powers of attorney, and other important documents that care for your loved ones, reflect your values, and support the causes you believe in. This workshop will give you a good overview of the financial considerations involved in the planning process and how best to use various annuities, trusts and other vehicles to help reduce your tax exposure and maximize your gifts to family and charity. Worship and query: How do I identify, develop, and use my particular gifts for the good of all?

Welcome, recognition of first time attenders, review of agenda

We welcomed first-time attender Lee Steel.

Review of minutes for December Meeting for Worship with Attention to Business Approved.

Annual Report of ARE—Dan Darnell (Attached)

Dan began by reading the annual report from 1967–68, as an interesting comparison and reflection back to our early history.

One Friend expressed gratitude for ARE's outreach to involve other committees in the Meeting.

Another expressed strong support for ARE's investigation into improving our sound system. Buildings & Grounds is exploring options, including possibly installing microphones in the ceiling. They will be reporting to the Meeting soon about what they learn.

The report was accepted with appreciation for the work of the committee.

Recommend transfer of membership of Wendy Michener from Fayetteville Friends Meeting to Chapel Hill Friends Meeting

We approved Wendy's transfer of her membership back to CHFM. Dottie Heninger is convening a committee that is in the process of planning a welcoming potluck for the first Sunday in February. The committee is composed of Dottie, Tom Munk, Kitty Bergel, and Carolyn Stuart. Announcement of this potluck will be going out on the listserv.

Approved.

Continuation of Discussion of Benevolences—Bill Jenkins and Dan Darnell (Attached)

See benevolence descriptions posted on our website. There are also a few hard copies on the table in the foyer.

Our clerk reminded Friends that this month we are approving only the ARE and P&SC benevolences, having approved those under the stewardship of M&W last month, and also that the overall amount for benevolences was approved at a previous meeting and represents a 10% cut from last year's total.

Bill described P&SC's process of discernment, having come to clearness on spreading out the cut by giving a greater portion to organizations who have not done as well financially this past year, and less to those who are doing better. Bill asked Friends who might want more money given to any one group, to suggest what group we might take that money from. After some discussion, we went into silent worship.

One Friend expressed ongoing frustration with what he perceived as the Meeting's avoidance of the unfolding tragedy of the degradation of the environment. Friends honored this Friend's concerns, but also pointed out the ways that we are indeed addressing this need, including increased monies to environmental benevolences, increased efforts by the ECC to educate the Meeting, and the indirect environmental benefit of the work of some these organizations (e.g., Friends Committee on National Legislation). The Meeting was united in its concerns about environmental damage, and in our need to look more closely at what we may be able to do as individuals and as a community.

While there was sadness expressed at some of the cuts to some beloved benevolences, and understanding of this Friend's concern, we approved P&SC's benevolence budget. Several Friends expressed thankfulness for the time we allowed ourselves to discern and come to unity, and recognition of the difficulties of P&SC's task.

ARE's benevolence is the Friends' Center at Guilford College. Dan asked Friends for help learning about this benevolence. Matt shared what he knew about the Center, its being the Quaker Center on campus, similar to other denominations' centers on college campuses. Wendy shared that the Center sends ministers to unpastored meetings that want them, and that Deborah Shaw does outreach work with students. One Friend noted that we have cut many benevolences that are important to us and should consider whether this benevolence remains a priority.

We asked ARE to take another month to learn about the Friends' Center, and decide how the benevolence money should be allocated.

ADULT RELIGIOUS EDUCATION Annual Report 2011 - 2012

The adult religious education committee is carrying on and furthering many initiatives that have been noted in prevous annual reports We are very conscious and intentional about encouraging certain aspects of forums, ie. that forums are relevant in clear ways to both Quaker faith and practice, have some specific structure, and a clear process for engaging participants. We strive to have the forums represent well the diverse activities, both in social action and spiritual development, that members and committees are involved in. We often get feedback that forum participants value highly the small group sharings around specific queries. In that light the personal sharings by individuals in the Meeting are also greatly appreciated. This has led us to be more intentional about furthering opportunites for such sharing and for enhanceing the sense of community in the Meeting. There also seems to be a recurring interest in organizing small groups of members and attenders who can meet on a regular basis outside of First Day, e.g. for a book club, but ARE has not recently been actively involved in promoting this.

We have frequently discussed how to collaborate effectively with other committees, for example, sharing ideas for forums with Ministry and Worship, and supporting the planning done by the Meeting's 75th Anniversary committee. We have focused some on working with CRE to involve the children in forums in order to appreciate their unique perspectives and to facilitate interactions among different generations in the Meeting.

We seek to have forums that highlight what it means to be a Quaker and what Quaker processes are. This is an area that we often have extended discussions about and for which we seek guidance from Ministry and Worship. ARE is aware of the importance of supporting ways the Meeting engages with our community, our nation, and the world at large. There have been forums on environmental concerns, FCNL initiatives, Quaker House, engaging with the Muslim community, and the Occupy movement.

Another area to make progress on is collaboration with Buildings and Grounds to enhance the audio/visual capabilities in the Meeting House. There has been much feedback that forum attenders would appreciate a better sound system. We have also tried to maintain some consistency in recording forums and collaborating with the library committee to make the audio CDs available in the library.

Current members of ARE are Barbara Williamson, Dirk Kelder, Max Drake, Marilyn Dyer, Ryan Jarrell, and Dan Darnell, convener. Of note too are the significant contributions to the committee's work that Andy Nelson and Emily Nelson have made earlier this year.

MINISTRY AND WORSHIP ANNUAL REPORT: 75TH ANNIVERSARY YEAR (2012)

The Ministry and Worship committee is responsible for supporting and nurturing the spiritual life of the Chapel Hill Friends Meeting. Because 2012 was CHFM's 75th anniversary year, we had many opportunities to celebrate and to commemorate our past, our present and our future. A forum in January with Deborah Shaw of Guilford University, entitled "Making a Place for Deeper Things to Happen" served as a keynote address for the year's journey; it was followed by a forum in February to develop ideas for connecting our committees' work with our members' spiritual growth and for developing better communication among committees and between committees and our greater community. Instead of our usual Spiritual State of the Meeting meeting in March, we decided to make this a yearlong examination of our spiritual state and our desire for improving communication.

A course facilitated by Lloyd Kramer (meeting on 2/12, 3/11, 4/8, 5/6, 9/9 and 10/14) considered the writings of Ben Pink Dandelion. Participants (numbering between 25 and 50 per class) discussed CELEBRATING THE QUAKER WAY, CONFIDENT QUAKERISM, and LIVING THE QUAKER WAY in preparation for a day-long workshop led by Ben Pink Dandelion and Deborah Shaw in November. At that workshop, the morning was devoted to "Why We Do Things the Way We Do" and the afternoon dealt with "Building Quaker Community for the Next 75 Years." Two forums, led by Ministry and Worship, dealt with the implications of that workshop and where we go next.

In addition, Ministry and Worship put together a time line of our meeting, summarizing significant events in our history and we continue to supervise the creation of a tapestry related to our meeting's ministries (still in progress). We organized meeting members and attenders to send more than 75 letters to the Chapel Hill Town Council in support of the Interfaith Council's Good Neighbor Policy as the next step in moving the men's shelter to its new location. We sponsored meeting trips to Sword of Peace, to Pathway to Freedom, and to Quaker House in order to revisit our influences and impact.

At the Clerk's request, Ministry and Worship recommended and facilitated an adjustment in our early meeting schedule to give Business Meeting 30 additional minutes to accomplish its agendas in a more worshipful manner, we sponsored the 2012 Clerks' Retreat, we hosted an ice cream social for all those people who use our meeting house, and we supervised both the high school graduation forum in June and our Christmas Eve celebration. We formed clearness committees for membership for Ryan Jarrell, Ed and Cindy Bowen, Andrea Wuerth and Herbert Struemper and their daughters Milena and Lily, Jasmine McKewen, and Rodney Burrell.

We are grateful to our convener Jan Hutton and our members Max Drake, Pat Mann, and Larry Tabor, all of whom rotated off in July, and to Carolyn White (an invaluable ex officio member of M&W). We are thankful to the meeting for the use of benevolence funds to support many of our 75th anniversary activities. Last, we appreciate the members and attenders of this vibrant and growing meeting for rising to this year's challenges and occasions.
