#### **Welcome Naveed Moeed**

At the September 1st potluck, we will welcome sojourning friend Naveed Mooed. Please join us. Below is a brief biography of Naveed:

Naveed is a 39 year old, British-born Pakistani, who not content with being from two countries has chosen to live in more. From the shores of Denmark and the canals of Amsterdam to the deserts of the Arabian Peninsula, he has come to rest (for now) in Chapel Hill. Originally an Astrophysicist he left the glitz and glamour of academia to work in Identity and Privacy solutions, which he now does for a large telecommunications firm. Naveed came to Quakers by convincement, having encountered silent worship at his alma mater, the University of Kent at Canterbury. His enthusiasm for the rights of individual privacy stem from the modest work he has done in Peace and Social Witness, as part of Reading Monthly Meeting in the UK (now Mid-Thames Area Meeting). Naveed is an enthusiastic bridge player and avid cyclist.

## **IFC News: New Executive Director Appointed**

The Inter-Faith Council for Social Service (IFC) is pleased to announce the appointment of John Dorward as executive director of the agency. By a unanimous vote at its August 21st meeting, the IFC's board of directors appointed Mr. Dorward to the position to replace Chris Moran, who retired as executive director as of July 1st.

Mr. Dorward joined the agency in 2003 as finance director, was appointed associate executive director in 2008 and became interim executive director upon Mr. Moran's

retirement. "I am honored to be chosen by the board of directors to help lead the IFC in this, our 50th year," said Dorward. "With the help of the staff, board and our hundreds of community volunteers and supporters, we can continue the work of the IFC for another 50 years. Having worked with Chris Moran, the IFC's long-time executive director, for the past decade, I have a good grasp of the agency's mission and vision."

Mr. Dorward brings thirty years of non-profit management experience and a commitment to the underserved to his new position. Before joining the IFC, he spent 23 years with Ipas, another non-profit organization in Chapel Hill, in a variety of positions including executive vice president, CFO and corporate treasurer.

"John Dorward is the perfect leader for the Inter-Faith Council for Social Service at this time in our history," said Rebecca McCulloh, president of the IFC board. "John brings the experience, skills and savvy that we need to complete the capital campaign for the new Community House, build that facility, and launch the FoodFirst initiative."

Mr. Dorward and his wife Pat lived in Orange County for most of their 34 years together. They now live just across the line in Durham's Chapelwood neighborhood.

## Chapel Hill Monthly Meeting of the Religious Society of Friends Meeting for Worship with Attention to Business

#### Minutes August 18, 2013

Tom Munk, clerk; Robin Harper, recording clerk

**Worship and query:** When disagreements arise, are they recognized, discussed, and resolved with loving patience and forbearance? Are we able to celebrate our diversity without reservation?

- 1. Welcome, recognition of first time attenders, review of agenda We welcomed first-time attender Eric Nesman.
- 2. Review of minutes for June Meeting for Worship with Attention to Business Approved

#### 3. Report from Quaker House—Steve and Lynn Newsom

We welcomed the new co-directors of Quaker House, and Lynn back to her home meeting. Steve and Lynn outlined some of the projects they are currently working on, such as a new "Alternatives to Violence" program. With the domestic violence rate in the military nearly twice as high as in the community at large, Ft. Bragg has welcomed QH actually offering this program on base. They also offer programs on anti-sexual assault training, conflict resolution, mindfulness, and a Wounded Warriors support group, among others. They have been exploring taking advantage of community resources, such as concerts and local service providers. While the hotline counselors at QH continue to have a very high success rate in helping soldiers that need to achieve CO status, Quaker House has increasingly become known in the military community as a helpful resource, and perhaps less of an adversary. They focus on Chuck Fager's original sign: "We are against war but for our soldiers."

Quaker House has been working on international issues as well. Putting pressure on the government to end the use of drones and expose the use of torture has been a focus for Steve. He has attended Stop Torture Now meetings and protested at Johnson Airfield, where extraordinary rendition flights were originating.

Lynn and Steve invited everyone to come to Fayetteville to visit QH, get a tour of Ft. Bragg, or see the Military Museum. Friends are also invited to take part in work parties at QH, which have been very successful with young people and families who come to help with needed chores. All of Quaker House's work is funded by donations, so all gifts are welcome! You are also invited to "like" them on Facebook! Naveed Moeed offered to help them set up a Twitter account.

Lynn and Steve asked to be held in the Light during this Tuesday's Alternatives to Violence class, which will be attended by members of the military. The class will be from 2:00-5:00pm and from 7:30-8:30pm.

We expressed our thanks to Steve and Lynn for all of the great work they are doing.

#### 4. Peace and Social Concerns Annual Report—Bill Jenkins (Attached)

Friends asked if there members of Quaker House Board on P&SC, and there are. Other questions were raised about the difficulties in planning benevolence spending. A large part of the work of P&SC is the annual benevolence budget. Finance committee proposed thinking about changing the timing of this work. If the work was done in the winter, after Finance has a better picture of the Meeting's pending contributions, then Finance committee could then go to P&SC with this clearer picture. This could potentially make estimating the benevolence spending much easier. This will be explored by P&SC and Finance.

The committee has mounted a new (proposed) sign in front of the Meetinghouse, and asks Friends to take a look.

## 5. Proposal to change the name of the Peace and Social Concerns Committee to the Peace and Justice Committee—Bill Jenkins

There was extensive discussion surrounding this name change, including use of the words "witness" and "justice." Naveed reported that, in England, these committees are called "Peace and Social Witness" committees. The Meeting was not comfortable with the name change at this time, and referred it back to the committee for further consideration.

## 6. Letters of introduction for Rodney Burrell to Williamsburg and Virginia Beach meetings—Pam Schwingl (Attached)

Rodney will be released in early September and is moving to Newport News, VA. His support committee is working to find ways to support his transition. After some changes, Friends approved the attached letters of introduction for the two Virginia meetings, pending Rodney's approval.

Recommended change to letter: "We joyfully recommend Rodney to your Meeting."

#### 7. Membership for Alice Drozdiak—Lynn Drake

A Clearness Committee for Membership consisting of Pam Schwingl, Jan Hutton, Chris Stanley, and Lynn Drake (convenor) met twice with Alice Drozdiak. We experienced quality sharing with each other and were impressed by Alice's faith journey and her knowledge of Quaker faith and practice. The Committee on Ministry and Worship recommends that the Meeting approve the membership of Alice Drozdiak. A brief biography of Alice is below.

Joyfully approved.

Lynn Drake, Jennifer Leeman, and Naveed Moeed will plan a welcoming, convened by Lynn.

#### 8. Conscientious Objection letter from Rachel Leeman-Munk (Attached)

Rachel read her wonderful letter to us. Afterwards a Friends shared about Rachel and the great measure of Light that she holds. Another Friend praised her for the fact that she wrote this letter despite the fact that she did not need to, as a woman, to stand in solidarity with the men. He urged her to take her Light out into the World to share what it is to be a Quaker, and to be a CO.

Accepted with gratitude.

A Friend asked if we can we consider publishing this or another CO letter in a local newspaper (assuming writers are willing)? Curt Torell, Pam Schwingl, and Naveed Moeed indicated their willingness to form an ad hoc committee to explore this idea.

The Meeting approved setting up the above ad hoc committee, and asked that they also consider codifying the process so that it can be used for future letters.

Jennifer Leeman asked that we please hold Rachel in the Light as she moves to Boston to attend graduate school.

#### 9. Announcements

- a.At the September 1 potluck we will welcome Naveed Moeed as a sojourning member from England. We will also begin the process of introducing the youth at this potluck, to help the Meeting get to know them.

## PEACE AND SOCIAL CONCERNS COMMITTEE ANNUAL REPORT

#### Activities covering January 2012 to July 2013

**Benevolences:** A major work of the PSCC again this year was to prepare a report for the Meeting on the current mission, financial condition, and recommendation for funding for selected benevolences for our wider ministry. The Meeting's budget required an overall reduction of about ten percent. In recommending funding priorities, the Committee considered the current mission and program of potential benevolences in the light of the Meeting's interests. The Committee also weighed the benevolences' financial condition measured from financial reports solicited from the prospective grantees. In order to meet these restrictions some grants were eliminated and discussed strategies to increase funding in the future.

**National Quaker Service:** We also scrutinized with care requests from individual Friends for grants to participate in National Quaker Service.

Middle East concerns: In response to our recommendation, the Meeting joined other faith groups in supporting local bus advertisements calling for the United States to end military aid to Israel. We co-sponsored with the Abrahamic Initiative for the Middle East (AIME) a wellattended forum April 14 at the UNC Global Education Building on the subject of human rights and military aid to Israel.

**NC Legislature:** Our committee helped to foster participation in Moral Monday rallies at the state capitol, and one of our members testified at a legislative committee meeting against proposed restrictions on voting. In addition, the committee purchased a quarter page ad for the NAACP Freedom Fund.

**Forums:** As a member of the Orange County Peace Coalition, we co-sponsored a forum held at the United Church on April 6 to highlight urgent local needs in education, health, and infrastructure. Subsequently, with the Coalition, we successfully petitioned the

Orange County Commissioners and the towns of Chapel Hill and Carrboro to urge Congress to bring the war dollars home to meet local needs. Other forums included Human rights for the LBGT community and prison reform and re-entry.

**Police in schools:** Several on our committee have protested the potential hiring of police in the Hillsborough elementary schools, and one of our members has co-authored a report describing the negative effects of police in schools.

**Prisons:** As an outgrowth of our prison work, our committee has helped establish a separate committee, the Friends Transition and Support Committee. That Committee is primarily concerned with support and re-entry to the community of prisoners from Orange Correctional Center. The attorneys on our committee have provided counsel.

#### Future initiatives may include:

- \*Increasing visibility of the meeting's commitment to social justice by placing signs in front of the meeting house and on buses;
- •Increasing voter participation in NC through our efforts with the NAACP;
- \*Holding a meeting of Durham, Raleigh and Chapel Hill Friends social concerns committees to discuss joint activities such as Moral Monday and voter registration follow-up, as well as, producing signs "North Carolina Quakers for Social Justice" for distribution to meeting houses and for use in demonstrations;
- \*We are also proposing a name change from Social Concerns to "Peace and Justice" to emphasize our belief in "faith in action."

#### ALICE DROZDIAK BIOGRAPHY

My name is Alice Drozdiak. I grew up in rural western Pennsylvania and attended Dickinson College before moving to Chapel Hill in 2008 for graduate school at UNC. In 2011, I finished my Masters in Linguistics; I then taught English through the Orange County Literacy Council until spring 2013. Most of my students were refugees from Burma and Thailand, though I also had a chance to work with Latin American families through Carrboro's Centro Hispano. I also taught a class at Raleigh's detention center. In addition to my work with the Literacy Council, I volunteer with the Orange County Rape Crisis Center as both a Community Educator in public schools and a crisis Companion, responding to hotline and hospital calls. This fall, I will begin UNC's Masters of Social Work program, with a focus in international peace and conflict resolution.

My husband and I live on the outskirts of Chapel Hill with our dog, two cats, and rabbit. We began attending the Chapel Hill Friends Meeting shortly after I completed my degree. I originally wanted to attend because I was interested in silent worship. I was impressed with the respectful welcome we received, and we continued to attend off and on for about a year and a half before I decided to pursue membership. My time with my Clearness Committee solidified for me that Chapel Hill Friends Meeting was my spiritual home, and I would like to thank Lynn Drake, Jan Hutton, Pam Schwingl, and Chris Stanley for their guidance. #### CONSCIENTIOUS OBJECTION LETTER FROM RACHEL LEEMAN-MUNK

I believe that every person, no matter what they have thought or done in their life, has a purpose in this world. By ending a life, one is taking away someone humanity can and should learn from. I am not saying that everything we learn will be nice, or fun. I'm definitely not saying that the person has to be free of fault. What I am saying is that, whether or not a person is fighting for the "enemy", has committed a terrible crime, or holds a belief that we cannot condone, that person exists on this earth for a reason and should not be taken from it. These beliefs cause me to request status as a conscientious objector from all war.

I came to these beliefs throughout my life. I have always been peaceful. When I was small, I could not stand to kill anything, even bugs. I became vegetarian at the age of 9 because I could not stand to eat an animal I had seen grazing in a field. I never fought in school, or verbally abused other children. Once when I accidentally hurt my brother, I spent the next hour crying because I felt so badly about it. I learned a foundation for my beliefs within my community at the Chapel Hill Friends Meeting, where I attended with my family throughout my childhood. Quakerism is one of the traditional peace churches, and growing up in Meeting I gained a deep connection to the peace testimony. I also learned much of my nonviolence from the Quaker testimonies "equality". If I view all others as equal, how can one person deserve to live and another not? On that basis, how can killing another human being ever be okay?

I have been actively supporting groups that support nonviolence for most of my life. In middle school I supported People of Faith Against the Death Penalty during the fundraiser that takes place at my Meeting every Christmas. I had the sad opportunity to confirm how I felt about the death penalty when a close friend was killed in an accident with a drunk driver during high school. While her family initially tried to get the harshest penalties against the driver who killed their daughter, I forgave him and hoped that the court would help him redeem himself and become a fruitful part of society.

I had the opportunity to work directly with people with similar stories to the man who killed my friend the year after I graduated from college, when I spent a year working at the Durham Economic Resource Center. DERC is a non-profit organization in Durham, North Carolina that does job training and placement for people with criminal records, substance abuse history, and mental illness. One of the biggest things I learned from my year there was that a person can do unequivocally terrible things in his/her life and still have worth as a human being. I worked with people who redeemed themselves.

I am unwilling to participate in a system that does not give the "enemy" an opportunity for redemption, assuming they need to be redeemed at all. I have experienced loss and anger in my life. I know what it is like to desire retribution. However, I do not feel that I have the right to determine whether someone lives or dies. Human beings are so complex. I cannot possibly know all the reasons for why a soldier is participating in war. Even if I did know, I do not believe any human is capable of single minded killing. There are too many underlying reasons for every action. I do not believe that anyone is truly unforgivable, and therefore no one is worthy of death. Please accept this letter as my written statement of this belief.
