**Aug 27: "What's Up Downstairs?"** The Building and Grounds Committee will provide an update on the renovation of the lower floor of the Meeting house. Moderator: Catherine Alguire

**Sept 3: "Meeting Benevolences."** Participants will be led to share their leadings regarding the Meeting's benevolences and benevolence process. Led by Tom Munk and Naveed Moeed, Peace and Justice Committee. Moderator: Carolyn White

**Sept 10: "Friends House Moscow."** Karen Porter, Board member and past Clerk for Friends House Moscow, will talk about Quaker efforts in the Russian Federation today. Quakers, though few in number in Russia, coordinate many projects that benefit, for example, refugees, prisoners, orphanages residents, and families. Although military service is required, Russian law provides for conscientious objection; and FHM supports education about alternative service. FHM also sponsors international Alternatives to Violence Project (AVP) programs in Russia and Ukraine. Moderator: Andrea Wuerth

Sept 24: "Honoring the elders in our Meeting - peace and justice in the 60s." The elders of our Meeting have been invited to tell us what they did when they were young - 50 to 60 years ago! #### **Edwin Louis Brown**

Friends who were at Meeting in late May, when Michael Brown and his family placed Ed Brown's ashes in the Memorial Garden and then attended Meeting for Worship, might enjoy this history of Ed's quietly remarkable life.

Edwin Louis Brown, April 6, 1929-March 27, 2017

I think my dad and mom probably started attending meeting together in 1966. It's possible my dad attended previously. He was introduced to Quakers at Haverford when he started there in 1946. While there, he met Rufus Jones. My dad started attending the Asheville Meeting when he moved here in fall 2011. He attended until his stroke in May 2015 and continued afterwards until perhaps five weeks before he passed away.

I think my dad was probably on peace and justice committee in Chapel Hill. He was a regular at many events in front of the old post office. My mom was clerk of the meeting, perhaps immediately prior to Betty Flash.

Dad was a correspondent of Albert Einstein when a teen and later with King Hussein in his 60s. Dad wrote King Hussein trying to head off the first Gulf war and somehow the letter got through. King Hussein was moved to call in a favor to Ted Turner and made a speech on CNN saying his faith in the American people had been restored and he would redouble his efforts in the cause of peace.

Prince Bandar of Saudi Arabia soon thereafter attacked King Hussein and a Mr. Brown of North Carolina for advocating against war with Irag. I remember it as my folks hadn't told me that Dad

was having his 15 minutes of fame so I thought it strange when reading the NYT at college and seeing a reference to "a Mr. Brown of North Carolina." It gave me pause, but I thought it surely couldn't be my Dad as they would have told me something was going on. They hadn't.

I think both King Hussein and my Dad foresaw the cataclysmic events which were to follow US intervention in the region. They didn't head off the war, but I think they signaled as strongly as they could the problems that would follow. Dad became quite concerned about the lack of freedom for Palestinians around that time -- a long-time Quaker concern since 1948 -- and we grew closer as we learned together during my adult years about the conflict and I was able to share back with the Chapel Hill Friends Meeting about my time in Gaza. He became a strong supporter of Jewish Voice for Peace which I think grew out of his civil rights concerns from the 1960s.

Dad is survived by sons Michael and Benjamin Brown, daughter-in-law Ameena Batada, grandsons Amrit and Rayhan Brown, sister Mary Ida Sprague, and numerous nephews and nieces and their children and grandchildren (most of us in Asheville, but also Lousiana).

The Orange County Department on Aging, Project EngAGE, and UNC Wellness Health Education collaborate on a monthly program on EngAGING ISSUES--topics presented by experts to provide information and knowledge to our "growing wiser" population. Research shows that proactive coping can increase the chances of successful aging--and knowledge is a key step in the process to proactively cope, i.e., PLAN for aging.

- 1. We began with worship and consideration of the query: "When traveling or otherwise absent from Meeting for Worship, do I find other opportunities for worship?" One Friend spoke to her hope that we all find ways to worship wherever we are.
- 2. Minutes of the June 18, 2017 Meeting for Worship with Attention to Business were approved. with the addition of the names of Matt Drake and Robin Harper to those present.
- 3. Request for membership for Evangeline Rioux was brought to the Meeting by Jeff Brown and Jasmine McKewen for Ministry & Worship Committee. Jasmine McKewen read the following minute:

"On behalf of the Ministry and Worship Committee, I bring a recommendation to approve the membership request of Evangeline Rioux. A Clearness Committee for membership consisting of Jasmine Mckewen, Jeff Brown, and clerked by Leslie Rountree, met twice with Evangeline and were pleased to propose membership for Evangeline to the Ministry and Worship Committee. They agreed and this is their recommendation."

Jeff Brown then read the following brief biography of Evangeline:

"My name is Evangeline Rioux, and I am applying for full membership at Chapel Hill Friends Meeting. I am sixteen years old and a rising senior at Chapel Hill High School. I run track for the school and swim for the school team as well as competitively on both club and summer teams. My passions include writing- I recently attended CampWrite at UNC and wish to pursue a career in journalism- and dance. I have done ballet, contemporary, and aerial dance over the past five years, but have had to cut back recently in order to focus on swimming. # Friends approved Evangeline's membership into the Chapel Hill Friends Meeting.

Jeff Brown, Jennifer Leeman, and Jasmine McKewen volunteered to serve as her Welcoming Committee.

- 4. Ad Hoc Committee on Benevolences Matt Drake, Clerk, reminded us that, at the March Meeting for Worship with Attention to Business, we reviewed and approved Peace & Justice Committee's new process for considering annual benevolences, which included the creation of an ad hoc committee to consider new and continuing benevolences and make a recommendation to the Meeting in spring 2018. Friends were invited to serve on this ad hoc committee via the MWAB minutes, E-News, and after-Meeting announcements. The names of Jamie Jacobs and Lloyd Kramer have come forward. Asta Crowe indicated that she also would be willing to serve but is concerned about the possibility that she would be absent at times due to travel. We approved Jamie Jacobs, Lloyd Kramer, and Asta Crowe to serve on the Ad Hoc Committee on Benevolences for 2017-2018 with gratitude and with the hope that meetings might be scheduled around Asta's availability.
- 5. Update on proposed make-up and description of and resources and support for Meeting Trustees Matt Drake, Clerk, reported that work continues. If you have any questions, please ask Matt. Recommendations will come forward at a later date.
- 6. Nominations Committee's June 18, 2017 recommendation for three-year terms for Meeting "officers." Matt Drake, Clerk, referred to the original minute and the reasoning presented by Nominations. The committee noted that it may be appropriate for the same people to serve many consecutive terms and that a term end date enforces a check-in to determine if continued service is becoming an undue burden for the individual or is otherwise unwanted. Matt proposed that the original minute be changed by adding the "office" of Clerk of the Meeting and removing Trustees. The

first change ensures that all "officers" are included. The second change (note #5 above) reflects the current on-going discussion about trustees. The term limits for trustees will be considered at a future time.

A question was raised about limiting the treasurer's term to three years, given how long it takes to learn the position. Note was made that the treasurer could serve multiple terms but this allows time for both the meeting and treasurer to revisit how things are working every three years. Friends approved the recommendation of three-year terms for the Clerk of Meeting, Correspondence Clerk, Treasurer, Recorder, and Recording Clerk.

- 7. Report on the 2016-17 fiscal year budget Maura Murphy, Treasurer presented the report, noting that we collected enough contributions to make our budget goal. Committee co-clerk, Kitty Bergel, thanked Friends for making the contributions needed to meet our budget. We also raised \$119,000 for the renovation. Maura reviewed the amount we have in our various accounts and noted that we are in very good financial shape. **The report was accepted with gratitude to our treasurer.**
- 8. Report from Buildings & Grounds Committee on a possible Town of Chapel Hill requirement that the Meeting create an Americans for Disability Act approved parking space Don Hopper, Clerk of Buildings & Grounds Committee reported. He first provided an update on the construction. He explained how confusions with the electrical system have resulted in some of our lights being temporarily cut off. The downstairs has been gutted and doorways enlarged. He then moved to discussion of the possibility that we create a handicap parking spot that is van accessible, in other words, 19 feet long and 13 feet wide and close to a ramp with a gentle grade. We don't have an appropriate spot in our current lot. We may or may not have to create the space. We are exploring what is actually required by the Town. A decision will need to be made in the future about how we will proceed but there is no urgency at this point in time. A Friend suggested we might want to assess how well we are meeting the needs of older Friends and what we might need to do to address those needs.
