1. The meeting opened with worship and the query: "Am I guided by a reverence for all living creatures and a sense of the splendor of the Spirit's continuing creation?"

2. The clerk, Matt Drake, invited friends to review the agenda. Based on questions raised last month, he clarified that he will use the verb "accept" for committee annual reports and other items that are basically information sharing and "approve" for those items that require an actual decision by the Meeting.

3. The Minutes of the October 21, 2018 Meeting for Worship with Attention to Business were approved as printed in the newsletter.

4. Jan Hutton, Co-clerk Ministry and Worship Committee, presented the committee's annual report. One Friend spoke to appreciation for the Meeting celebrating all days as holy days and not singling out specific days, as is the practice in many faith communities. **The Meeting accepted the Ministry and Worship Committee's annual report with appreciation for the work of the committee.**

Ministry and Worship Annual Report 2017-2018

Reviewing the activities of the Ministry and Worship Committee this past year, we celebrate the cooperation/collaboration with other Meeting committees, Meeting members and attenders, and others who inspire our work and service. Our responsibility is to support the spiritual life of the Meeting with concern for the quality of our Meetings for Worship, Meetings for Worship with Attention to Business, and including a number of other roles, addressed below.

Recurring activities of Ministry and Worship include:

- The annual September Clerks' Gathering, attended by 25, including 6 non-clerks; *Planning for the Clerks' Retreat involves working with the Clerk of the Meeting on the agenda and inviting ideas from Committee Clerks on topics of interest for the retreat and then learning about the discernment and spiritual opportunity of clerking a committee. Additionally, process documents relating to clerking were streamlined and revised for the retreat, and are available on the Meeting website.*
- The October Spiritual State of the Meeting gathering, attended by 25; The Spiritual State of the Meeting allows us to reflect on issues through the lens of Piedmont Friends Yearly Meeting membership while sharing deeply with others on queries prompted by the Yearly Meeting
- At the request of Piedmont Friends Yearly Meeting (PFYM), each October we average the overall number of Friends and attenders in attendance at both Early and Late Meetings for Worship throughout that month;
- Our annual Christmas Eve Worship;
- Worship Sharing with Attention to Animals (guided by the Animal Welfare Subcommittee);
- Meeting for Worship with Attention to Graduating Seniors;
- Annual Contemplative Retreat in April;
- Forums, including in 2018, "Entering and Centering: Preparing for Meeting for Worship";
- Sending our monthly minutes to the Archives Committee dropbox for eventual inclusion, digitally, at Guilford;
- Discerning queries for each month of the year used in the e-news, newsletter, and read in the first part of Meeting for Worship. *We are grateful for recent feedback from Friends which will enrich the future query creation process*;
- Participation on clearness committees for membership and coordinating transfers of membership; We welcomed Bob and Winnie Simmons and Gwyn and Kurt Hein, as they transferred their memberships and were grateful for Sean Chen and his daughter, Matilda, who became, respectively, new and familial members.
- Continue to work with CYRE to coordinate the teens closing Late Meeting in months having 5 Sundays;
- After discussion with CYRE, M&W will annually offer an experiential and informational program on membership to the teen pod;
- With a brief announcement weekly, supporting the silencing of cell phones during Meeting for Worship;
- Designating a Closer for every meeting for worship.

Responding to emerging membership questions about the status of Young Adult Friends who have grown up in the meeting, an ad hoc committee consisting of Ministry and Worship, Care and Counsel, CYRE, and Archives Committee was created to address this concern. Their discernments resulted in re-defined membership levels, approved as a Minute at Meeting for Worship with Attention to Business. These enhancements are also listed on the website Membership page. M&W, at the request of several members, initiated an ad hoc committee to examine and address celebration practices for babies, grandbabies, and college graduates. Members of Care and Counsel and CYRE are also serving, for which we are grateful.

M&W plans to begin the process of exploring several ongoing opportunities for Quakerism 101- like programming, both experiential and didactic, which will be more readily available in the future.

An ad hoc committee has been created to research and address the topic of mass shootings and emergency preparedness at CHFM (and in everyday life.) This committee, including John Hite, has been at work for at least 5 months gathering pertinent information and having CHFM assessment visits with the Chapel Hill Police Department, as well as the Fire Department. A forum is planned to explore the vectors of meeting interest in specific areas.

Some of the continuing concerns of the M&W committee include: quality of vocal ministry, nurturance of Meeting committees, and attention to the quality of worship, including processes for beginning and ending worship, and the brevity of shared announcements.

With great gratitude, we thank departing members Ed Bowen, Lynn Drake, and Pam Schwingl for their faithful service.

5. Lynn Drake, Co-clerk Mary and Claude Shotts/Leadership Development Fund, presented the committee's annual report. She emphasized that the funds are not needs based and are available to all Meeting members and attenders. **The Meeting accepted the Mary and Claude Shotts/Leadership Development Fund annual report with gratitude for the committee's work.**

Shotts Memorial and Leadership Development Fund Committee Annual Report 2017-2018

The Mary and Claude Shotts/Leadership Development committee oversees two funds to support the leadings of Friends, both members and attenders, to enrich and deepen their capacity for leadership within the Meeting, the local community, and the Religious Society of Friends. The Mary and Claude Shotts Memorial Fund, established in 1973 from funds donated by members of the Shotts family, provides financial support to enrich and develop the lives of individuals with a relationship to the Chapel Hill Friends Meeting. Grants from this fund are distributed from the interest earned on principal.

The Leadership Development Fund, established in 1982, provides grants to benefit the spiritual life of the Meeting through the enhancement of leadership capabilities in individuals. Grants from this fund are distributed from money carried over from prior years and from annual allocations approved by the monthly meeting.

Friends Fiduciary manages the investments for the Shotts Memorial Fund, and year-end principal balance is \$34,436.43. From this fund, we received \$1,239.16 total in interest income for the 2017-18 fiscal year. Our fund balance in our BB&T account at the end of the fiscal year 2017-18 was \$3,142.26, carried forward to FY2018-19.

The support of the Shotts/ Leadership funds is not "need based." The Committee made additional efforts to communicate information about the funds through the newsletter, listserv, speaking with individual Friends. Grants made for the 2017 - 2018 fiscal year totaled \$1,560. The committee requested \$200 for the Leadership fund for the 2018-19 fiscal year. Friends who received support during the year included:

Others continue to serve: Roberto Quercia, Monteze Snyder, Susan Inglis, and Catherine Alguire. Ken Grogan, Lynn Drake and Asta Crowe are joining the committee effective July 1, 2018. Lynn and Asta serve as co-clerks.

6. Sean Chen, Clerk Publications and Communications Committee, presented the committee's annual report. Friends expressed appreciation for the role the committee plays in keeping us all connected and the need for additional friends to join the committee and/or assist with the work. Sean noted that Ed Bowen continues to assist with the eNews. **The Meeting accepted the Publications and Communications Committee annual report with appreciation.**

Publications & Communications Committee Annual Report, November 2018

The Publication & Communications committee edits, produces and distributes the monthly print newsletter and calendar as well as the annual directory. The members manage and update the Meeting website, the online calendar, and other online activities. They coordinate and send a weekly email newsletter and as needed "In the Light" announcements. The committee assists with other publications for Meeting committees as needed. One member should serve on the Archives Committee, however that is not being filled.

MARY EVELYN WATKINS JOHNSON June 9, 1928 – October 15, 2018

Mary moved to Chapel Hill with her husband Wendell in 1989. They attended Chapel Hill Friends Meeting regularly, always sitting together on the back bench on the south side of the meeting room. They also participated in Meeting activities. Mary was a regular volunteer at the IFC Kitchen on First Thursdays when our members prepare lunch for the homeless.

In 2005 Mary and Wendell moved into Carol Woods Retirement community. She continued to be involved with Quakers at Carol Woods, sharing a special dinner with them weekly. Mary eventually became Wendell's caretaker until the end of his life in 2008. They had been married 60 years.

Mary provided leadership in the Carol Woods library. She had earned her graduate degree in Library Science from Kent State. Throughout her life, books were always important; she particularly enjoyed a good mystery. Cash and Carry, Carol Woods' thrift shop, also depended on Mary's weekly volunteer hours. She participated in a women's group, and the daily coffee group where she discussed world events and – always – politics and issues of social justice.

Travel to visit her four daughters and their families was a high priority for Mary. She visited Christine and Rachel in California every year, and traveled to France to be with Sarah's family. Closer to home, she made regular trips to visit Martha on the Outer Banks.

Mary was a quiet, thoughtful presence, and friends will remember her broad smile. Her Light touched many lives.

CHARLENE WHISNANT SWANSEA May 27, 1932 - August 23, 2018

Charlene Swansea became a member of Chapel Hill Friends Meeting in the closing years of her life, in January 2014. We were pleased that she wished to become a member, completed the membership process, and was welcomed into Meeting. She had earlier been a member of Charlotte Friends Meeting.

Charlene always sat on a front bench in our Meeting, often accompanied by her son, Tom Whisnant. Occasionally, her husband Mark Oldenberg, would join her. She wore bright colors (often yellow or gold), and big floppy hats -- a vibrant presence in our midst.

Charlene's active life influenced many people, particularly in the South. She was a publisher of the <u>Red</u> <u>Clay Reader</u>, a literary magazine. Her contributors included poets, dramatists as well as literary critics. Her other careers included actor, writer, and teacher -- including leading poetry workshops in the Charlotte public schools. She later devoted her enormous energy and intellect to informing adults about how the human brain processes memories. She thought of herself as a neuroscience researcher and consultant, founding her business, Mindworks.

Charlene's life encompassed a rare combination of flamboyance and thoughtful reflection. Always, she was a perceptive, loyal friend. Her gifts of friendship extended equally to the famous and the downtrodden. She wanted writers to succeed, friends to know and share their unique gifts. Her life mission was encouraging others to find their passions.

She wrote how God spoke to her: "I did not create you to be sad, to cry for the world, but to be glad. Find beauty in everything. Open your heart and your eyes. There is a shuddering light and rocks that whisper, and rivers that sing, stars in the fire, fluttering wings. Drink them in. Ponder them and I command that you should celebrate these things." We are glad that Charlene Swansea was among us, grateful for the fullness of her life's work, and her admonishment to celebrate the beauty of our world.

9. Tom Munk, Co-clerk Peace and Justice Committee, provided an update on efforts to bring concerns about our country's support of the war in Yemen to our Congressmen. **The Meeting accepted the report.** Hart Pillow volunteered to join Tom Munk in his visit with Representative David Price; Tom Ludlow and Emilie Condon also may join. The suggestion was made that Tom post the resolution that FCNL is asking us to support to the eNews. At the request of a Friend, Tom also spoke about the First Step Act, which would make it easier for people getting out of prison to re-integrate. Senator Tillis has said he will support but it is not clear if Senator Burr will. Friends were encouraged to contact their senators on that topic as well.

Tom Munk's Update on the war in Yemen

Much has happened since I reported to the Meeting last month, but much remains to be accomplished. The United States has agreed to stop refueling Saudi flights over Yemen. Paul Ryan has successfully used a deceptive parliamentary maneuver to avoid a vote on ending U.S. support for the war. Two Democrats voted for the bill by mistake. But Senator Sanders is expected to force a vote soon after Thanksgiving in the Senate. The vote will be close, and if it passes, the topic will return to the House.

FCNL is encouraging Friends to reach out to our Senators, asking them to co-sponsor and vote for S.J.Res. 54, the Sanders-Lee-Murphy legislation that would end all U.S. participation in the Yemen war as a matter of law, rather than on the whims of a president.

I will be meeting with Rep. Price in his Raleigh Office at 3 PM on Tuesday. I will be driving from my office in the RTP. Friends interested in joining me, please let me know.

10. Don Hopper, Clerk of Buildings and Grounds Committee, presented the committee's recommendations for renovating the Meeting room. Friends raised concerns and suggestions about the materials used for the flooring and used to finish the flooring. They also provided suggestions for the amplification system. Finance reported that we have sufficient funds to cover the estimated costs of the renovation and any additional costs for the amplification system. In response to a Friend's question, Don reported that once approved, renovation should begin shortly with the goal of starting in late winter and finishing by July 2019 at the latest. Buildings and Grounds Committee's recommendations will be held over for a decision in December. Friends were encouraged to bring questions and concerns to members of the committee. Gratitude was expressed for the work of Don Hopper and the committee.

Report from Building and Grounds

The Buildings and Grounds committee has come together in unity on a recommendation of aspects for the Meeting room asked for by MWAB in April of 2003. These recommendations are as follows:

- Remove existing ceiling sheetrock and the insulation above. Install new sheetrock and trim (small crown, chair rail, 6" baseboard) prime and paint. Premiere Painting and Home Improvement \$12,000
- Demo existing lights, install 12 new recessed LED lights, add receptacles for valence lighting Dynamic Electrical solutions \$2800
- Valence to be supplied by Meeting \$2000 dimmable LED tape lights.
- Install Armstrong Faux Wood Surface Mount Acoustical Plank Ceiling Tiles Premiere Painting and Home Improvement \$2600 labor, Meeting supplies Tiles \$2500
- HVAC reworking of return grills and supply grills
 Warren Hay Mechanical budget number \$1500-2000
- Install and Finish new Select White Oak T&G hardwood floors NC Floor Guys \$13,600
- Install Tcoil friendly hearing loop \$ unknown Investigation ongoing Prices seen for medium sized location \$5000-\$10000 This may be something Meeting can tackle.

11. Announcements:

A. A memorial service for Marilyn Dyer was held on Sixth Day, November 16. The Meeting community and friends from Carol Woods and the Jung Society participated. Matt Drake expressed gratitude to all who helped.

B. Meeting for Worship with Attention to Business will meet next on First Day, December 16th, at 9:00 a.m.

C. The Hospitality Committee has come to unity on using compostable plates at potluck and to take the plates, paper napkins, and discarded food scraps to the Recycling Center on Eubanks Road. The reasons for this decision are threefold: (1) Sanitation, (2) Maximize fellowship and minimize clean-up, and (3) Compost more and consume less fossil fuel by changing to the use of compostable plates at potlucks D. Friends were asked to sign up to help Hospitality greet people on First Days at 11:00 a.m. and also to sign up to host Friends to a Thanksgiving meal at home or to participate in a Thanksgiving meal at a Friend's home. Sign-up sheets are on the door of the Meeting house.

E. Pecans are available in the library from the fundraiser for the prison ministry. The Brunswick stew will not be available this year, and Richard Miller is working on refunding the money.
